

### 4 Process/Rules

The Devices A LA Carte **Jubilee** promotion can only be executed via the A1S Automated Discounts module via the Avaya One Source tool and Channel Marketplace using the following process:

- 1. Create a new merchandize or configured quote at Avaya's One Source tool
- 2. Ensure that the quote is in Ready to Order status.
- 3. Process the quote through A1S Automated Discounts, applying the appropriate promotion code (list of promotion codes in Appendix B). Select "Apply Promotion/Program".
  - Once redirected to the A1S Automated Discounts page, enable the radio button for the Devices A LA Carte Jubilee promotion discount. Click <u>Apply Selected</u>. Your quote will now be in "Ready to Order (Pending Action)" status
  - Click on the "Pending Actions" link on the A1S Quote Center page to display all Pending Actions for the quote (there may be more than one e.g. SFDC opportunity and approval routing).

  - a. End Customer Name
  - b. Summary of existing Avaya Aura and/or IP Office deployment details Save and Submit the Approval Request. The Request will be emailed to Avaya will review your request and target approval/rejection within 2 business days.
- 4. An approval email will automatically be sent to the requestor once it is processed by the Approver.
  - If approved, the quote will move to 'Ready to Order' status so the quote can be ordered as normal
  - If rejected the quote will also move to 'Ready to Order' status, but the promotion discount will be removed.
  - New quotes and quote modifications for this promotion can be made up to and including the end date as on the front page of this offer definition but will require approval
